


GROWTH OF A \$10,000 INVESTMENT¹





¹The fund commenced operations after all of the assets of a predecessor mutual fund were transferred to the fund in exchange for a corresponding class of shares of the fund in a tax-free reorganization on 9/6/02. Inception date prior to 6/6/02 reflects the inception date of the predecessor fund's corresponding share classes (Class R). Performance reflects current distribution fees in effect only since 6/6/02 and includes returns for the predecessor fund. BNY MELLON MASSACHUSETTS INTERMEDIATE MUNICIPAL BOND FUND – CLASS M

Goal/Approach

The fund seeks as high a level of income exempt from federal and Massachusetts state income taxes as is consistent with the preservation of capital.

To pursue its goal, the fund normally invests at least 80% of its net assets, plus any borrowings for investment purposes, in municipal bonds, the interest from which is exempt from federal and Massachusetts state personal income taxes. The fund also may invest in municipal bonds that are exempt from federal income taxes, but not Massachusetts personal income taxes, and in taxable bonds.

The fund's investments in municipal and taxable bonds must be of investment grade (i.e. Baa/BBB or higher) quality at the time of purchase or, if unrated, deemed of comparable quality by the investment adviser. Generally, the fund's average effective portfolio maturity will be between three and ten years and its average effective portfolio duration will not exceed eight years. The fund may invest in individual

municipal and taxable bonds of any maturity or duration.

In calculating average effective portfolio maturity and average effective portfolio duration, the fund may treat a security that can be repurchased by its issuer on an earlier date (known as a "call date") as maturing on the call date rather than on its stated maturity date.

Portfolio Management

The investment adviser for the fund is BNY Mellon Fund Advisers, a division of The Dreyfus Corporation.

Mary Collette O'Brien and Stephen J. O'Brien are the fund's primary portfolio managers, positions they have held since March 2006 and September 2015, respectively. Ms. O'Brien is a managing director of The Bank of New York Mellon, an affiliate of The Dreyfus Corporation. Mr. O'Brien is a senior associate of The Bank of New York Mellon. Ms. O'Brien and Mr. O'Brien also are employees of The Dreyfus

Corporation and manage the fund as employees of The Dreyfus Corporation.

Certain Risks

The fund is subject generally to interest rate, credit, liquidity, call, and market risks, to varying degrees, all of which are more fully described in the fund's prospectus.

Generally, all other factors being equal, bond prices are inversely related to interest-rate changes and rate increases can cause price declines.
