Transaction Activity	Indicates various transactions that are incoming, outgoing, or those requiring verification, funding, and/or release; offers the ability to drill down to the transaction to complete the required work flow
Create Payment	Initiates intra-company transactions via free-form or pre-established templates; intra-company transfers can also be assigned to pre-established groups.
