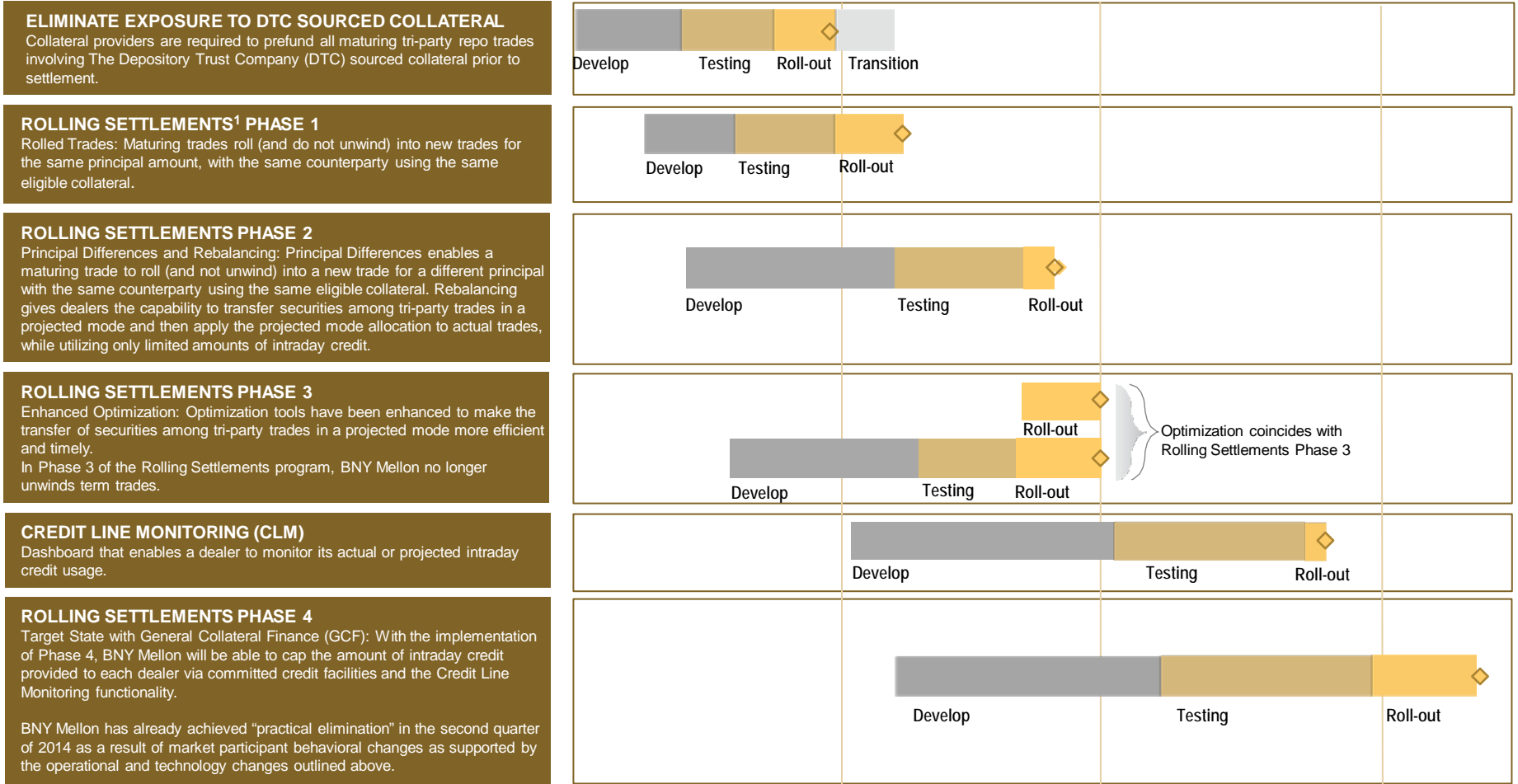


BNY Mellon U.S. Tri-Party Repo Infrastructure Reform Program Timeline
