Zara, Cambridge University Women's Boat Club: It's great that I can do something that I really love, and that I'm really passionate about, and now it will also help Cancer Research UK. It's really good for the sport as well, and for getting people active and getting people involved.

Anne-Marie, BNY Mellon: I just feel really proud of the organisation and really glad to work for a company – and companies – that's willing to do something like this that is so game changing.
